# *Humble Physics* Teacher Who Blows His Own Horn

Scott Barton, ninth-year Physics teacher at San Marino High School, plays a number of roles.

> here's the calm, controlled Robotics advisor who never raises his voice above the level of polite dinner conversation, and the self-described "rocker," blasting his trombone as part of the South Pasadena Transit Authority and other tribute bands.

"I love music," says Barton, who you may have heard as part of his other tribute band, *The Grateful* Dads, playing in Garfield Park as a regular part of the South Pasadena Summer Concert Series. The science-music connection merely scratches the surface of Barton's versatility. He also has a passion for World History, which he teaches during summer. And it might surprise you that teaching wasn't Mr. Barton's first career.

After receiving his undergraduate degree from Iowa State, Barton earned his master's in Business at UCLA before signing on at Rawlings Sporting Goods, where he was an engineer-in-charge of product development and research. Scott had the opportunity to take a year-long hiatus and used that time for a bit of soul searching.

"I was tired of the corporate world," he said. "The travel... all of it. I took a personal inventory. I knew I liked science and math. I had coached my son Nick's Little League and AYSO teams and was a Boy Scout leader, so I knew I liked being around young people. The problem was that since both of my parents were teachers, I had sworn I would never teach. So, of course, I became a teacher. But it was the best decision I ever made in my life."

His students and coworkers couldn't agree more. As the Chair of San Marino High School's Science Department, Barton took over as advisor of the Titanium Robotics team. Under his guidance, the team has become one of the most successful organizations at SMHS.

"We do very well for the number of students involved in our program," Barton said. "Our students are involved in several extracurricular activities and we routinely compete against technical high school and academy teams often dedicated only to Robotics."

"The kids are great here," Barton said. "They truly want to learn, and I am so grateful for the facilities and teaching tools the District provides -- with the Schools Foundation's financial support. It makes San Marino High School a wonderful teaching and learning environment."

Scott's own offspring have attended San Marino schools. Son Nick is a 2011 graduate of San Marino High School, and last month graduated from Purdue with a degree in Conservation Biology. As a parent, Scott has received numerous awards including Valentine's Heart of Gold, the Huntington Halo Award, the Terrific Titan, and also a PTSA Founder's Day Service Award.

Barton says he will be teaching at least another dozen years. So, look for him and his horn in local music groups, or even on stage with San Marino High's Jazz Band. "I'm not going anywhere," Barton said.

# Foundation Fundraising Saved Teaching Position *Of Beloved Mrs. B*

At Valentine Elementary School, students may call her "Mrs. B," but there is much more to first grade teacher Judy Buranasakorn's story than the shorthand moniker suggests.

udy knew at the tender age of ten she wanted to be a teacher, but her journey followed a rather circuitous route that has ended up pretty close to where it started.

She grew up just around the corner as a native of Alhambra and is a graduate of Alhambra High School. She went on to attend the University of California, Irvine, before spending three years as a tax consultant with Deloitte. After six years in the private sector, her true passion spoke so loud, it could no longer be ignored.

"I would use all of my vacation and sick time to volunteer at schools," Judy admitted. "I would chaperone field trips, teach dancing, make sure kids got to camp... and I still had my day job. But I just loved the kids!"

"Since I was in the fourth grade," said Mrs. B with a chuckle, "I used to play 'school' with all of my cousins, and they were always the students." She smiled as she recalled composing handmade worksheets for her "students" to complete.

Mrs. B's dream of teaching transported her to Point Loma University, where she earned her master's degree, then to Cal Poly Pomona, where she earned her teaching credential. Valentine was her first teaching assignment, and she's still happily a member of the Vikings faculty. Her life circle even included a return to Alhambra, where she now resides with her husband, Ron, a 6th grade history teacher at South Pasadena Middle School.

"We met on the first night of teacher's school," Judy says with a touch of emotion. The couple has been filling out lesson plans together ever since. Their family has been growing -- recently adding 20-monthold son Moa (Hawaiian for "freedom") and anticipating the July arrival of son Koa ("bravery").

"One of the many things I love about Valentine is the sense of community, where everyone supports each other," Buranasakorn said. "The parents support the teachers, the teachers work together with the families. We are a team. San Marino is very unique in the dedication and support of the San Marino Schools Foundation."

The eleven-year veteran and Heart of Gold Award recipient knows the power of this dedication first hand. "Several years ago, there was a 'Reduction in Force' and I was pink-slipped with many others," Mrs. B explained. "There was a huge outpouring of support to raise the money to save our jobs. A lot of parents I knew tirelessly worked phone banks until that money was restored. I was hired back immediately with no interruption, and we were honored and thankful that the community came together to help us. Such commitment from our community proves beyond any doubt that they place education first."

# Kelly McCrary Has The Courage It Takes

In author Parker J. Palmer's 1998 bestseller The Courage to Teach, Parker writes in the introduction, "This is for teachers who have good days and bad — and whose bad days bring the suffering that comes only from something one loves."

> hough separated by almost two decades, Parker and 2015 San Marino High School graduate Kelly McCrary might be kindred souls based on those words.

"I want to be an elementary school teacher," Kelly said recently, without a nanosecond of hesitation. "I love working with kids."

"Hesitation" itself is a foreign concept to the daughter of Alison and Mike McCrary. Kelly was captain of the cross country and track teams. In the classroom, the Bucknell University-bound McCrary was named Student of the Year by the Rotary Club of San Marino. She was a member of the Senior Class Advisory Board, the esteemed California Scholastic Federation, Omegas Service Club, National Honor Society, and she capped the school year by being tabbed one of only thirty-four Prometheans. She has certainly made the most of her days in San Marino.

Kelly traces her desire to teach back to her childhood. "I have always loved working with kids," she said. "I have younger siblings and a lot of younger cousins and family friends, and I always felt like I was the teacher of the group." For her Girl Scout Gold Award project, Kelly created a summer fitness program for pre-schoolers at La Cañada's Child Education Center.

As her inspirations, Kelly recounted almost too many teachers to mention. "There are different characteristics of each one that I admire. Each of them is very unique, and they all love their work. They want you to become better citizens, not just better students."

Like many before them, the McCrary Family migrated to San Marino for the schools. "My parents both went to public schools, and they wanted the same for us," said Kelly. She is being followed closely by her sister, rising-junior Cameron - a member of the Lady Titans' championship golf team - and Alexandra (Alex), who will be a freshman at SMHS in August.

Kelly says, "I had so many great opportunities. Whether it's academics, sports, or the visual and performing arts, it is a unique atmosphere and a great environment."

But now, it's off to Bucknell and life in a different time zone. "They have great academics and a great education program," Kelly says. "I like the way I felt on campus. Everyone was friendly and welcoming. I felt as though I really fit in." When reminded of the climate difference from Southern California to Pennsylvania, Kelly laughed and said she is "getting some sweaters and a warm jacket. I am looking forward to experiencing something other than Southern California."

# First Impressions Sold San Marino To The Zhang Family

A journey of more than six thousand miles begins with a single step – and a friend's recommendation.

> t least that's how it worked for Karen Hua Zhang and Ye Li. While moving to the United States to open a branch office for their company, Fujian Xianzhilou Biological Science and Technology Co. LTD., they needed to find the right schools for their two children, Sheries You Cheng Li, who is entering the seventh grade at Huntington Middle School and a son, Richard Hai Cheng Li, who will be a fourth grader.

"We visited a number of cities and San Marino created the best first impression," said Ye. Drawn in by the beautiful surrounding, the great schools, and it's well educated community, they found San Marino was the perfect fit. The existence of a strong Chinese community was important to Ye. "We felt it would make the transition much easier" he explained.

Fujian Xianzhilou Biological Science and Technology leads the world in biological research, cultivation, manufacturing and marketing of nutraceutical products. For more than twenty years they have been extracting the full potential of the ganoderma mushroom genus (reishi in Japanese) which has been used in Chinese medicine for thousands of years in the treatment of immune disorders, bacterial, fungal and viral infections. Earlier this year, the philanthropic Mr. Li was honored at the United Nations for sharing his technology and agricultural techniques throughout Africa, Vietnam, the Phillipines and Malaysia, improving the health of locals and giving poor farmers an opportunity to make more money due to the high profitability of ganoderma.

"We love San Marino," said Karen. "We enjoy our children's classmates and their families. All of the parents help out unconditionally. We love the teachers and feel as though they are always there for our children. People are very friendly...and we love Lacy Park".

The Zhangs have enthusiastically supported the San Marino Schools Foundation since coming to San Marino. "Once we understood the importance of the foundation in our children's education we didn't hesitate in supporting its efforts" said Ye. "The best public schools in China are fully subsidized by the government and families are never asked to provide additional funding. However, in the United States we realized the best school districts must have additional financial support from families in order to lower class sizes and employ the best teachers."

"We've been around for quite a while," Billy's mother Nicolette says with a sigh and a smile. # **Charitable Planning And Our Schools**

People often ask "How can I best help our schools?" Every year community members devote thousands of hours through volunteer activities to make our schools better and most give their financial support through the Annual Campaign. However, many still feel they want to do more but are not sure of the best plan or financial vehicle. Here are some ideas to get you started.

## **Cash** Donations

Suppose you would like to make a \$10,000 gift to the San Marino Schools Foundation. If you write a check for \$10,000, you will receive a \$10,000 charitable income tax deduction. If you are in a 35% income tax bracket (federal and state) and itemize your deductions, you will reduce your taxes by \$3,500 (\$10,000 x 35%). The net cost of your gift will be \$6,500. Make your pledge during the InfoSnap School Registration process.

## Appreciated Stock

Instead of giving cash, you could donate \$10,000 of publicly-traded stock you purchased ten years ago for \$2,000. First, just like a gift of cash, you will be able to claim a \$10,000 income tax charitable deduction. In addition, you will avoid paying the capital gains tax you would have paid if you had sold the stock rather than giving it to charity. By donating the stock instead, you will forever eliminate this potential tax liability. By giving stock instead of cash, the net cost of your gift will be further reduced from \$6,500 to \$4,900.

## Matching Gifts

Many corporate matching programs will donate dollar-for-dollar. It's a great way to increase your gift's value. Consult with your Human Resources Department for more information. Matching gifts can help you effectively double your gift to SMSF.

## Gift of a Principal Residence

The gift of a principal residence while retaining the use for life is an additional charitable gift technique that is simple and easy to accomplish with a minimum of paperwork and expense.

## **Donor Advised Funds**

Set up your own donor advised fund with a community foundation or another financial institution. You can leave a lasting legacy to the San Marino Schools Foundation.

## Charitable Trust

Many techniques using trusts are available that, while more complicated, can result in significant benefits. These trust techniques include charitable remainder trusts that can result in additional cash flow to the donor while also obtaining a charitable deduction that saves on income taxes.

- Usually funded with cash or appreciated securities.
- · Get an immediate charitable tax deduction.
- · Can minimize capital gains, estate and current income taxes.


